

# Pathways

- The journey to employment
- Step by step
- Involvement, confidence building
- Tackling barriers
- Training
- Links to Enterprise
- Jobs or Self Employment or Social Enterprise





# Merseyside, England

- Worst off areas (a third of Merseyside)
- Local Partnership Residents, Enterprises, NGOs, Local Government, National Government, Colleges.
  Perhaps a large firm, or hospital, or police
- Local People also created a Pathways group, so that they could be represented on the Local Partnership
- Later, Pathways representation on the Monitoring Committee





## Pathways Partnership

- Money to meet and research
- Existing statistics for the local area often poor quality or did not exist
- More consistent small area statistics (school qualifications, free school meals, unemployment, state benefits)





## The process

- Set up a local Partnership
- Build trust and understanding
- What are the problems for the area?
- What resources are there (including ESF and ERDF)
- What can we do?

# Liverpool City Region CES

- Special status some EU 2007-13 direct to the area
- Local Government and NGOs and Enterprises
- Joined up thinking
- Challenging targets qualifications, unemployment
- Partnership working

- Funding to support the unemployed
- Intermediate Labour Market
- 6,300 short term jobs

- Support for Enterprise (not branding the wiring)
- Procurement local jobs for local people
- North West Construction Hub simplification
- Housing Compact on Worklessness, Apprentices
- Skills for Growth Agreements
